**PROGRAM CONSENT & RELEASE FORM**

By signing below, I give permission:

- For my child to participate in the M.o.R.E. for Kids program;
- For the Mentor matched with my child, who has been screened and approved by M.o.R.E. for Kids, to transport my child to events and match activities;
- For the school to provide social and academic information about my child to M.o.R.E. for Kids;
- For my child to participate in an in-take interview conducted by M.o.R.E. for Kids staff and to answer questions throughout their time in the program about school, home life, personal interests, and their match;
- For my child to talk with M.o.R.E. for Kids staff about personal safety;
- For M.o.R.E. for Kids staff to provide contact information for me and my child to a Mentor.



- I understand that the program is not obligated to match my child with a volunteer and that as part of the enrollment process I will be asked to provide additional information through an in-person interview.
- I understand that the information I provide in the enrollment process will be kept confidential unless disclosure is required by law and with exceptions noted.
- I understand that incidents of child abuse or neglect, past or present, must be reported to proper authorities.
- I understand that certain relevant information about my child will be discussed with the Mentor who is a prospective match.
- I certify that all of the information on this form is true and correct.
- If my child is matched with a Mentor, I agree to support my child's match by reviewing the safety information given to me by M.o.R.E. for Kids staff, communicating with M.o.R.E. for Kids staff as outlined in expectations (which includes communication at least once a month in the first year of the match), and immediately reporting any concerns I might have to M.o.R.E. for Kids staff.
- I hereby grant M.o.R.E. for Kids consent to use my child's first name, image, quotations and/or writings in any publication or production made in media of any form, including but not limited to: paper publications, television, photography, audio or video recordings, social media sites and websites. The use of this information shall be at the sole discretion of M.o.R.E. for Kids.
- I understand and agree that all publications, productions, media and images created or used by M.o.R.E. for Kids as described above are the property of M.o.R.E. for Kids, and are owned by them, and that neither my child nor I are permitted to authorize their use by any other party.
- I hereby release M.o.R.E. for Kids from all claims, demands or liabilities and related financial costs that I or my child may now or hereafter have arising in connection with M.o.R.E. for Kids' exercise of the rights hereby granted. These include, without limitation, claims for compensation, defamation, or invasion of privacy, or other infringements or violations of personal or property rights of any sort whatsoever.
